### NASSAU COUNTY CRIME LAB

The American Society of Crime Laboratory Directors Laboratory Accreditation Board inspected the Nassau County Police Department Forensic Evidence Bureau Laboratory from November 7<sup>th</sup> through November 11, 2010. As a result, they placed the Nassau County Crime Lab on probation. Nassau County Criminal Court Bar President (and 18B Panelist) Bill Kephart provided me with a copy of the 27 page ASLCD Lab Inspection Report. If you would like a copy, please return the enclosed request form and we will fax it to you.

A new copy machine being installed in our office this week will enable us to communicate with all of you by email in a manner that is far easier than our present ability to do so. #### **FAMILY COURT EXPERTS**

I was recently questioned by some Family Court Judges and Panelists concerning what experts we will and will not pay for. Please note that we **will** pay for forensic evaluations – where the expert interviews parents, children and any ancillary third parties, and evaluates situation. We **will not** pay for parent coordinators (-where the expert acts as an arbiter between two parents who are at each other's throats). We **will not** pay for therapeutic visitation (-where the expert accompanies a child during visitation because the child is uncomfortable with one or both parents). We **will not** pay for psychiatric therapy (- where the expert helps a party through a particular problem).

#### **JUDICIARY LAW § 35 (8)**

Family Court Panelists are reminded that if you are assigned in Supreme Court to represent a party in a Family Court type case, that representation is through Judiciary Law § 35 (8) and not through Article 18B. The fee in such case is **paid through the** State and not by this office. State vouchers, not 18B vouchers, should be used. This was all explained in my January 30, 2007 letter which can be found on our website (nassau18b.org) under "Admin Letters". Please check there for further information.
