### **SPECIAL WESTLAW OFFER FOR 18B PANELISTS**

After seven months of dealing with personnel from Lexis/Nexis, trying unsuccessfully to get a better deal for 18B Panelists, I finally told their representatives to forget it.

After one day of dealing with personnel from Westlaw, I received an offer for discounts of up to 40% on their books and online services for new customers. **THIS OFFER IS ONLY FOR 18B PANELISTS AND IS ONLY VALID THROUGH NOVEMBER 30, 2006.** I have included particulars of the offer at the end of this letter, including contact information for Scott McAndrews, the West Group representative. If this offer is of interest to you, you should communicate directly with Scott, before November 30<sup>th</sup>. If you have any problems, call me.

## **USE OF EXPERTS**

It is impermissible to use an expert who is not on the 18B Experts' Panel. If you need an expert and cannot find one on the Experts' Panel, call me to discuss the matter. Do not retain an outside expert on your own. If you do, any voucher submitted by such outside expert will be returned to you.

## **CLOTHES FOR DEFENDANTS**

In the event that your client is going to trial and does not have civilian clothes, do not go out and buy clothes. The Legal Aid Society has clothes for such situations and they have always been generous in working with us.

## **SERVICE OF DEMANDS FOR SUPPORTING DEPOSITIONS**

When serving a Demand for a Supporting Deposition pursuant to C.P.L. § 100.25, you should serve it on the Court and not the District Attorney's office.

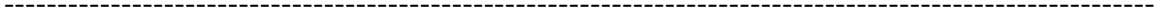
